વિધાનસભા ચૂંટણીમાં ભાજપ નવા ચહેરા સાથે આપનો મુકાબલો કરશે

ગુજરાત વિધાનસભાની ચૂંટણી જાહેર થઈ જતા રાજકીય પક્ષો પોતાના ઉમેદવારો જાહેર કરી રહ્યા છે. કુલ ૧૮૨ બેઠકો માટે થનાર ચૂંટણીઓમાં આમ આદમી પાર્ટીએ ઉમેદવારો જાહેર કરવાનું વહેલું શરૂ કર્યું હતું પણ હજી તેમણે ૧૫૦ બેઠકો માટે જ ઉમેદવારો જાહેર કર્યા છે, જ્યારે કોંગ્રેસ દ્વારા પ્રથમ રાઉન્ડની ૮૪ બેઠકો માટેના ઉમેદવારો જાહેર કર્યા છે, જ્યારે ભાજપે એક સાથે ૧૬૦ ઉમેદવારો જાહેર કર્યા બાદ વધુ ૬ નામ પણ જાહેર કરી દીધા છે. તેથી હવે સત્તા પક્ષ ભારતીય જનતા પાર્ટીના ઉમેદવારોની રાજકીય ચર્ચા શરૂ થઈ ગઈ છે. ભાજપે પોતાના ઘણા પ્રમુખ ચહેરાને અલગ કરી દીધા છે, જે ચર્ચાનો મુખ્ય મુદ્દો બન્યો છે. ખાસ તો વિજય રૂપાણી, ભૂપેન્દ્રસિંહ યુગલસા, મદીપસિંહ જાડેજા અને નીતિનભાઈ પટેલ સાથે ૩૮ ધારાસભ્યને ભાજપે પડતા મુકવા છે. આ પરિવર્તન કરાયાં હોવાનું કારણ આમ આદમી પાર્ટીએ ચૂંટણી મેદાનમાં ઝંપલાવ્યું હોવાનું છે. આમ આદમી પાર્ટી નવા ચહેરા સાથે મેદાને આવી છે તો ભાજપ તેનો મુકાબલો નવા ચહેરા સાથે જ કરવા માગે છે. પંજાબમાં આમ આદમી પાર્ટીને નવા ચહેરા સાથે ઉત્તરવાનો ઘણો લાભ થયો અને તેણે એક પ્રકારે ત્યાં કોંગ્રેસ અને અકાલીદળનો સફાવો જ કરી નાખ્યો. આ કારણસર ભાજપ નવા ચહેરા લાવી રહ્યો છે, જેથી તેમના પર નિયંત્રણ રાખી શકાય.

૨૦ વર્ષના શાસનકાળને જોતાં ભાજપ કંઈક નવું કરવા માગે છે જેથી મતદારોને નવી રીતે આકર્ષી શકે. આવું કરવાથી જો કોઈ સત્તાવિરોધી મોજૂ હોય તો તેનો સામનો કરવામાં પક્ષને મદદ મળશે, સાથે જ યુવાનોને આગળ લાવવાથી સંગઠનમાં નવો ઉત્સાહ પેદા થશે. ઉમેદવારો નક્કી કરવામાં સંગઠનને ઉત્તરવાનો પ્રિભાવને પણ ધ્યાને લીધું છે. મોટા ભાગના ઉમેદવારો ઠગેશી પપ વર્ષ વયના છે. ઘણાની ઉંમર તો ૪૦ કરતાં પણ ઓછી છે. સૌથી નાના ઉમેદવારની ઉંમર ૨૮ વર્ષ છે. મહિલાઓને પણ ટિકિટ અપાઈ છે. પરંતુ પ્રથમ સૂચિમાં તેની ટકાવારી માત્ર નવ ટકા છે. જેમાં ક્રિકેટર રવીન્દ્ર જાડેજામાં પત્ની રીવાબા પણ સામેલ છે. ઘણા ધારાસભ્યો એવા છે જેઓ ૧૯૮૦થી ચૂંટણી લડતા આવી રહ્યા છે. હવે તેમના સ્થાને નવા ચહેરાને તક અપાઈ રહી છે. કામ ન કરનારા ધારાસભ્યો વિરુદ્ધનો આકોશ ઘડાડવા માટે પણ હાલના ૩૮ ધારાસભ્યોની ટિકિટ કપાઈ છે. ભાજપે એવા કોંગ્રેસી ધારાસભ્યોને સામેલ કર્યાં છે, જેમને સંપૂર્ણ જોર લગાવ્યા છતાં પણ તેઓ હરાવી શક્યા નહોતા. આ એવા ધારાસભ્યો છે જેઓ નરેન્દ્ર મોદીના મુખ્ય મંત્રી તરીકેના કાર્યકાળ અને બાદમાં મોદીલહેર છતાં ગુજરાતમાં કોંગ્રેસની ટિકિટ પર ચૂંટણી જીતતા રહ્યા છે.

ગુજરાતમાં 'વિકાસ'ના મુદ્દે સત્તા ટકાવી રાખનાર પક્ષ ભાજપે હવે આમ આદમી પાર્ટીના પ્રચાર અભિયાન અંગે પ્રતિક્રિયા આપવા આગળ આવવું પડી રહ્યું છે. પાછલા ઘણા મહિનાથી મોદી-શાહની માફક દિલ્હીના મુખ્ય મંત્રી અને આમ આદમી પાર્ટીના રાષ્ટ્રીય સંયોજક અરવિંદ કંજરીવાલ પણ ગુજરાતમાં વધુ સક્રિય બન્યા છે. ગુજરાતમાં ચૂંટણીમેદાનમાં સફળતા હાંસલ કરવાના પ્રયાસમાં આમ આદમી પાર્ટી ભાજપને કેટલાક એવા મુદ્દે પ્રતિક્રિયા આપવા મજબૂર કરી રહી છે, જે ક્યારેક ભાજપના પરંપરાગત મુદ્દા હતા.

"We shouldn't expect Dave Chappelle to serve as society's moral compass, but disturbing to see ('Saturday Night Live') not just normalise but popularise anti-semitism," Greenblatt wrote. "Why are Jewish sensitivities denied or diminished at almost every turn? Why does our trauma trigger applause?" Notably, the Anti-Defamation League itself has not released a statement regarding Chappelle's 'SNL' appearance. The organisation had previously published statements regarding West's anti-semitic remarks, as well as Brooklyn Nets player Kyrie Irving's decision to share an anti-semitic film to his social media followers.

Hyderabad, Nov 14 Veteran Tollywood actor Krishna was hospitalised after he complained of breathlessness on Monday. The superstar of yesteryears was reported to be depressed since the death of his wife Indira Devi in September. In January, he lost his elder son Ramesh Babu. -IANS

### Tesla opens its EV connector design to other automakers

San Francisco, Nov 12 (IANS) Elon Musk-owned electric vehicle company Tesla has started to allow other automakers to use its EV connector design.

The Tesla charging connector, which combines AC charging and up to 1 mega-watt of DC in a "slim package", is the most well-known connector in North America, the company said in a blogpost.

It is half the size, twice as powerful, and has no moving parts compared to Combined Charging System (CCS) connectors.

"We invite charging network operators and vehicle manufacturers to put the Tesla charging connector and charge port, now called the North American Charging Standard (NACS), on their equipment and vehicles," the EV maker said. "Tesla's Supercharging network has 60 per cent more NACS posts than all the CCS-equipped networks combined," it added. NACS is the common charging standard in the US. Tesla owners can expect charging at other networks without adapters as network operators already have plans in place to implement NACS at their chargers.

"We look forward to future electric vehicles incorporating the NACS design and charging at Tesla's North American Supercharging and Destination Charging networks," Tesla said. "We are actively working with relevant standards bodies to codify Tesla's charging connector as a public standard."

### Vistara announces non-stop flights between Mumbai & Muscat

New Delhi, Nov 12 (IANS) Vistara on Saturday announced non-stop flights between Mumbai and Muscat, the capital of Oman, starting from December 12.

### Blast in Istanbul likely act of terror: President

Istanbul, Nov 14 (IANS) Turkish President Recep Tayyip Erdogan said the blast that hit Istanbul on Sunday was likely an act of terror.

"Although it is too early to confirm 100 per cent, initial reports and information from the governor's office show (the blast) smells like terror," Erdogan said at a press conference in Istanbul before heading to Indonesia for the G20 summit.

"It looks like a single woman had a role in it," added the President, noting a full-scale investigation was underway. Xinhua news agency reported. Earlier, reacting to the blast, Erdogan has said that the security and health units were sent to the scene of the incident, and the wounded were quickly transferred to the surrounding hospitals. He also asserted that efforts to take over Turkey through terrorism will not work. India conveyed its condolences to the Turkish government and people following the blast.

India's External Affairs Ministry spokesperson Arindam Bagchi in a tweet said, "India conveys its deepest condolences to the Government and people of Türkiye on the tragic loss of lives in the blast that took place in Istanbul today. Our sympathies are also with those who sustained injuries. We wish them a speedy recovery." An explosion hit the busy pedestrian Istiklal avenue on the European side of the city at 4:20 p.m. local time, killing at least six people and wounding 53 others.

### China renews alert for drought

Beijing, Nov 14 (IANS) China's national observatory has renewed an alert for drought, as multiple regions continue to experience a lack of rainfall.

Moderate to severe drought lingers in some areas of Zhejiang, Anhui, Jiangsu, Hubei, Hunan, Jiangxi, Guizhou, Guangxi, Yunnan, Chongqing, Sichuan, Fujian and Guangdong, Xinhua news agency quoted the National Meteorological Centre as saying.

It said that extreme drought has hit parts of Hunan, Guizhou, Chongqing, Jiangxi, Hubei and Guangxi.

From Tuesday to Thursday, parts of the south-western, eastern and southern regions of China will experience moderate rains, with some areas expecting heavy downpours, according to the Centre's forecast.

While the precipitation will bring some relief, drought-affected areas are advised to monitor the weather closely and continue their drought prevention and relief work.

## Russia's proposed export duty on fertiliser to increase import prices by \$70/ton: Prabhudas Lilladher

Chennai, Nov 14 (IANS) The proposed 23.5 per cent export duty on fertiliser exports by Russia will increase

the cost for India by about \$70 per ton, as per a report by Prabhudas Lilladher Pvt Ltd. In the research report,

Prabhudas Lilladher said while the majority of Russian fertiliser exports are to Europe, there will be trickle down impact on India as well. "The cost of imports is

likely to go up by about \$70/tonne. However, we understand that the recent government announcement on reduction in fertiliser subsidy for 2HFY23 doesn't get

changed," the report said. The Indian government has already closed their book for FY23 (in terms of subsidy allocation). According to the report, the subsidy for FY24

is likely to be elevated and the domestic industry is likely to stock up imported fertilisers in 3Q for Di-ammonium Phosphate (DAP), Nitrogen, Phosphorous and Potassium (NPK) and Muriate of Potash (MOP) to some extent for the next kharif season.

The industry would be in a position to pass this on to the farmers, the report notes. According to Prabhudas Lilladher, Russia

will impose an export duty of 23.5 per cent on all types of fertiliser with a "cut-off price" set at \$450/tonne.
